Birthday Memory Options: (1) Birthday-in-a-Box: A box of toys and a Build-A-Bear for the younger birthday children, plus a Schnucks Market gift card (sponsor) for mom to buy a cake and treats. Older children receive gift cards and hygiene/beauty products. (2) Birthday Surprise: The birthday child or mom is able to select a gift from Amazon, allowing them to get exactly what they want. The gifts are delivered to the shelter for the mom to wrap and give to their child. (3) Birthday Party: A fun-filled celebration at the shelter with decorations, games, entertainment, and treats! Multiple children are celebrated. Each birthday child gets a toy, and moms receive hygiene/beauty products, making the day special for everyone! (4) Happy Born Day: We provide mothers who give birth while in the shelter their choice of items from Amazon—with things for baby and for mom. We want mom to know she is special. (5) Birthday-in-a-Class: This is also offered on behalf of the mom to celebrate the child with their classmates. Unfortunately, we have not done any since 2020.

OUR BIRTHDAY HEROES: THE HEART OF EVERY CELEBRATION


